The conservation of Cady Hill Forest

is within reach,

but only with your help.

Thanks to Stowe voters, the idea of a 320 acre town forest in the heart of Stowe is on the verge of becoming a reality. Thoughts of a forest abundant with wildlife and natural beauty, miles of trails dipping and winding through the forest drawing visitors to our community was all voters needed to support the Town of Stowe's Capital Budget which allocated \$288,000 of the local options tax to the purchase of Cady Hill Forest. The Town Meeting Day approval for the project was a strong commentary on the values held by our community, and your faith in our abil-

ity to complete this acquisition for the Town.

Your membership support has allowed us to spend the last 9 months working on behalf of our community to permanently conserve Cady Hill Forest.

Instead of 90 new houses scattered along the ridge above Route 100 as you enter the lower Village, there will remain a forested hillside. Rather than fragmented habitat and a lost trail network, there will remain a home for deer and woodland creatures, and recreational opportunities that attract visitors, support our economy and add to our quality of life.

Once purchased, Stowe Land Trust will donate Cady Hill Forest to the Town of Stowe to be merged with Macutchan Forest's popular "town loops" trails. The resulting protected area will host over 11 miles of multi-use trails that are popular with hikers, trail runners, dog walkers, and mountain bikers.

Thanks to a generous state grant, private foundation support and voter-supported town funding, Stowe Land Trust has raised nearly \$1,100,000 specifically for the purchase of this spectacular forest. Now more than ever, we need you, our members, to help us success-

fully complete this project. Our goal is to raise \$450,000 by May 30, 2012, and every contribution counts!

This spring also brings a moment of quiet reflection as we learned of the passing of Fred Chase, who in 2008, put some of his seemingly boundless energy into helping SLT conserve Maple Run. We

also pay our respects to Muriel "Moo-Moo" Wiessner who passed away in November 2010. Twenty years ago, Mrs. Wiessner dedicated an 80 acre forest in memory of her husband. Today Wiessner Woods is Stowe Land Trust's most popular conservation area and a beloved refuge - the perfect place to visit on a cool spring morning.

- Partnered with the Waterbury Conservation Commission to raise awareness about the Route 100 wildlife corridor.
- Provided assistance to the Waterbury Conservation Commission on a possible land protection opportunity along Route 100.
- Provided assistance to landowners in Morrisville and Brownsville on various options for conservation.

Mill Trail undergoing repairs last fall.


- Completed significant trail improvements at Mill Trail, including a 35 foot pedestrian bridge.
- Received a \$67,500 grant from the VT Housing Conservation Board to restore the historic Mill Trail Moravian Cabin.
- Worked with a UVM graduate student to complete an ecological assessment of Mill Trail for an updated management plan.
- Installed signs and trail markers at Kirchner Woods.
- Worked with UVM interns to complete resource inventories at Kirchner Woods for an updated management plan.
- SLT staff and volunteers completed and documented annual monitoring visits for all 28 properties conserved by SLT.
- Dedicated 100's of staff hours to assist owners of conserved land with achieving their management objectives.



Membership & Finance

Membership continues to be the driving force behind our operations, contributing 75% to our annual operating income. The Pinnacle Society, launched in 2010 as a way to recognize members who are at the foundation of SLT's ability to achieve its mission, represented 59% of membership contributions in 2011.

It is very important to us that the community see the results of their support of this organization. We are rewarded with a steadily increasing membership with 63 new members in 2011 and 75% of our members renewing each year. 15% of members in 2011 were friends that joined again after missing a year or two. Welcome back!

Our planned giving program was established to ensure the long-term care and management of lands conserved by Stowe Land Trust. For many people, planned giving options offer the opportunity to make a more substantial gift than would be possible during one's lifetime. Wiessner Woods 20th Anniversary

Sunlight slants through the trees and owls can be heard calling to one another above the background twitter of song birds and other forest noises. The trails at Wiessner Woods are easy to follow with decades of use leaving a well worn path as they wend their way through great stands of Hemlock.

Twenty years ago on December 30th, Muriel Wiessner (known fondly as Moo Moo) deeded the 80 acre forest to Stowe Land Trust. For Moo Moo the signing of the deed was the culmination of a dream shared with her husband Fritz, the renowned alpinist and ardent conservationist who passed away a few years before she donated Wiessner Woods in his memory. She made the donation to Stowe Land Trust because "it was local" and she "wanted someone who would care for the land they loved."

Wiessner Woods became Stowe Land Trust's second conservation project following the facilitation of the acquisition of Mayo Farm by the Town of Stowe. SLT's Board of Directors approached their newly conserved land with thoroughness and care so that it has grown to be one of Stowe's most popular conservation areas.

Shortly after acquiring the property, SLT's newly created Stewardship Committee set to work developing a parking area and signed

trail system. Committee members included Howard Carroll, Charlie Burnham, Johannes von Trapp, George Stearns, Gerry Kirchner and Greg Federspiel.

Moo Moo's passion for wildlife, particularly owls, made it easy to decide on a logo for the property. Graphics illustrator Lynne Jeffrey, generously donated her talent to create the owl image pictured here and featured prominently on signage and the brochure. Moo Moo and Fritz were actually the adopted parents to two Great Horned Owls: Miss Camelia and O'Higgins. This adventure is chronicled in the winter 1994 issue of Mountain Views. During the months of September and October 1993, the first of three trails was constructed. The Meadow Trail was officially opened to the public during a dedication ceremony where Moo Moo unveiled a plaque memorializing the conserved parcel in honor of her late husband. The Hardwood Ridge Trail, formerly known as Dead Horse Alley, and the Sugarhouse Loop were constructed the following year.

Little has changed for visitors walking Wiessner Woods twenty years later. Fairy houses and the recently disintigrated Gnome Home have added to the magical quality of the woods.



New bridges, culverts and trail surfacing have made the trails more sustainable for the many hikers, skiers, dog walkers and families that regularly visit Wiessner Woods.

Moo Moo's sentiments about SLT being local and committed to caring for the land she and Fritz loved still resonate as we celebrate 25 years of land conservation in our community. Protecting the land we love is still at the core of SLT's mission. Wiessner Woods was among the first to mark the beginning of a quarter century conserving forests, farms, scenic views emblematic of Stowe and recreation trails that make this a wonderful place to live and visit. Whether you visit Wiessner Woods everyday or for an occasional ski, you know the trails are a treasure. Make a point to bring someone new there this year and introduce them to Fritz and Moo Moo's beloved land.
