**EXPRESS ASSUMPTION OF RISKS AND FORUM SELECTION AGREEMENT**

I understand and accept the fact that the sport of running, in its various forms, contains inherent and other risks and dangers and is a potentially hazardous sport that can cause serious injury, permanent disfigurement and/or death, and could cause damage to my property. Some of the risks include, but are not limited to, accidents resulting from and/or related to variations in terrain, rocks, bumps, ruts, waterbars, tall and/or slippery grass, trees, tree roots, logs, bridges, changes in soil conditions, foliage, other runners and other related hazards both natural and manmade; as well as the presence of vehicles and other recreational activities. I further understand that trail running is very different than street running, presenting unique challenges, both physical and mental, and that the mountain environment offers constant changes in weather conditions and running surfaces.

I accept and understand the following: that activities involving use of the premises of Mt. Mansfield Company, Inc., d.b.a. Stowe Mountain Resort (herein SMR), Golden Eagle Resort (herein GER), and Trapp Family Lodge (herein TFL) for the Run for a Reason Stowe Trail Race Series are inherently risky, and may result in severe personal injury, property damage, or death. By use of the equipment, area and facilities of SMR, GER and/or TFL I freely, willingly and expressly accept and voluntarily assume any and all risk of property damage, personal injury, or death which might occur as a result of my participation in this event or the use of any equipment related thereto.
