n June 29, 2000 the Stowe Reporter ran a cover story with the headline "Bingham Falls Sale Galvanizes Preservationists". The community had learned the week before that the 40 foot cascading waterfall and surrounding gorge had been sold to developers. Since 1880 the McMahon and McSweeney families had owned and managed Bingham Falls and the surrounding undeveloped land.

With landownership changing hands and a threat to public access of the popular swimming hole, SLT and its partners began a conversation about permanent protection of this statewide treasure.

The future of Bingham Falls continued to be a hot issue throughout the rest of the year. Headlines and editorials in the news read "Bingham Falls Access in Doubt", "Bingham Falls Future Up to Stowe Voters", "Think Before You Vote to Buy Bingham Falls", and "Bingham Falls the Soul of Stowe"

It wasn't until January, 2001 that a sales agreement was reached with Old Colony

Construction Company and funders were approached about supporting the \$1 million project. Funding for the acquisition came from the Vermont Housing and Conservation Board, the Freeman Foundation, the Lintilhac Foundation, private individuals and the Town of Stowe. The community passed a ballot measure by a 2:1 margin to contribute up to \$300,000 to permanently protect the cherished natural feature. In April, 2001 SLT



purchased 72 acres including Bingham Falls, transfering ownership to the State of Vermont while retaining a conservation easement.

Even though Bingham Falls had been privately owned, has long been used by the public for swimming and recreation. Managed by the State of Vermont as part of Mt Mansfield State Forest, the property is regularly visited by swimmers on hot summer days. It is also used for hiking, snowshoeing, picnicking, ice climbing, cross country skiing and other low impact activities.

Just like in 2001, Stowe Land Trust continues to be humbled and grateful for the overwhelming support the community shows for protecting our special places. Thank you!

Celebrate Bingham Falls with a visit. You can access the property from Route 108, look for a gravel pull-off just before the entrance to Smugglers' Notch State Park. For a different perspective of the Falls, take the trail from the SLT owned Mill Trail property off Notchbrook Rd. Visit www. stowelandtrust.org for more information. Tax Incentives for Conserving Your Land in 2011

If you are considering a conservation easement donation, now may be the time to act. Landowners who donate a qualified conservation easement in 2011 will be able to:

- Increase their charitable deduction from 30 percent to 50 percent of their adjusted gross income (AGI) in the year of their gift (qualified farmers may deduct up to 100 percent of AGI); and,
- Carry over any unused deduction for up to 15 years, instead of 5 years.

The Scoop On Dog Poop

t's this time of year when the snow is melting and the streams are running high that we are reminded of winter's dog walking indiscretions. Suddenly the trails are

littered with pet waste we optimistically hoped would disappear before the snowpack dwindled.

Scooping your dog's poop isn't just a courtesy for those walking behind you; it is also the healthy and environmentaly friendly thing to do.

healthy and environmentaly friendly thing to do. Pet waste can be a significant source of water pollution. When not properly disposed of, it can

be carried by rain or snow runoff into nearby streams. Pet waste can also carry bacteria that is harmful to people and pets. Being part of the solution is easy. Carry a bag with you when you take your dog for a walk so you can scoop it, bag it and dispose of it properly. When there is no trash can

available, as on many of the lands conserved by SLT, you will have to carry it out.

> Throwing bags in the woods or leaving them beside the trail is not proper disposal because it does not remove the waste from the environment.

The next time you visit Wiessner or Kirchner Woods with your dog don't forget to bring a bag!

During spring mud season, trails are particularly vulnerable to erosion because of excessively wet conditions. Hikers are asked to stay off high elevation trails until Memorial Day. Several conserved properties around Stowe are good places to stretch your legs this spring. The trail at Pinnacle Meadow is a great walk with an amazing view of town. Check out the Blood Root wildflower population along Alex's Trail on the SLT owned DuMont property in Moscow.

2010 Annual Report A Year in Review

Land Protection

- Worked with a landowner on feasibility for conserving a 20+acre property in the West Hill area. Awarded VHCB grant for scoping.
- Conducted site visits with landowners in Stowe village, Stowe Hollow, and Elmore Mt. Rd, interested in protecting their land.
- Worked with landowner in Stowe Hollow on estate planning.
- Worked with The Nature Conservancy on a land protection partnership opportunity in Morristown.
- Partnered with the Town of Stowe and trail user groups to identify and prioritize threatened recreation resources.
- Supported the Waterbury Conservation Commission with conversations with a local farm owner about options for conservation.



Stewardship

- Constructed 64 foot long pedestrian bridge to re-establish public access across the Ranch Brook to Adams Camp.
- SLT staff and volunteers completed and documented annual monitoring visits for all 28 properties conserved by SLT.
- Worked with Cushman Design Group to assess public access to the Mill Trail Moravian Cabin and develop recommended structural improvements.
- Completed significant trail improvements at Wiessner Woods.
- Designed and installed kiosks at Wiessner and Kirchner Woods.
- Constructed 3 miles of trail and a parking area at Kirchner Woods.
- Dedicated hundreds of SLT staff hours to assist owners of conserved land with achieving their management objectives.
- Installed boundary markers at Kirchner and Wiessner Woods.

- Earned national accreditation from the Land Trust Accrediation Commission.
- Hosted a snowshoe, wildflower walk and mountain bike ride to celebrate our conserved lands.
- Conducted trail work with numerous youth volunteer groups including the Laraway School, VYCC, and Blessed Sacrament Bible Camp.
- Celebrated National Trails Day with a volunteer trail work day at Wiessner Woods.
- Held grand opening celebration for the trails at Kirchner Woods with friends and family members of Jerry Kirchner.
- Held several successful events including a wine tasting, the Stowe Land Jam, the Stowe Trail Race Series, the 11th Annual Golf Tournament, Pie in the Sky's Benefit Bake and an Ember Photo slideshow which helped us raise funds for conservation and connect with our community.

Membership & Finance

Stowe Land Trust launched the Pinnacle Society in 2010 as a way to recognize those members who are the foundation of SLT's ability to respond to land conservation opportunities and provide high quality stewardship over time. At the close of 2010 we were pleased to report that sixty individuals, businesses and foundations had joined as Charter members contributing 45% of SLT's annual operating income.

Membership continues to be the driving force behind our operations, contributing more than 65% to our annual operating income. Three quarters of our members renew each year and we are steadily increasing our membership with 45 new members in 2010. 11% of members in 2010 were friends that joined again after missing a year or two. Welcome back!

Our planned giving program was established to ensure the longterm care and management of lands conserved by Stowe Land Trust. For many people, a bequest offers the opportunity to make a more substantial gift than would be possible during one's lifetime. Three individuals contacted us in 2010 to let us know SLT was named in their will.

Preparing for the Next Twenty Five Years

According to the Land Trust Alliance, over the next 40 years the U.S. will add another 100 million people to our landscape, placing extreme pressure on our most exquisite natural areas, precious agricultural soils, and dwindling wildlife habitat.

Clearly, the need for robust local land trusts is stronger than ever. At a time when many are questioning big government and increasing property taxes, land trusts offer an efficient, local approach to protecting clean water, wildlife habitat, key recreation lands and our working farms.

As Stowe Land Trust approaches its 25th anniversary, we believe that a comprehensive strategic plan is necessary to guide our work, maximize the pace of land protection, make the best use of our resources, and truly act on our community's conservation desires.

To that end, SLT hired a consultant in January to shepherd us through the process of developing a 3 year strategic plan. This plan

will guide SLT in putting systems in place to sustain a healthy Board, pro-active planning, and thoughtful land conservation.

But our goal is also to develop a plan that's a reflection of our members and the community as a whole. SLT began gathering input in 2009 by soliciting feedback through a survey to our members. SLT also hosted a community leader's forum to gather input on issues ranging from our geographic focus, to fundraising, to the kinds of land protection projects that resonate most. This process helped us understand where we should focus our resources and how best to protect the lands that are most important to this community.

While land protection remains at the core of SLT's work, other goals, such as ensuring the lands we've conserved are maintained and managed for their conservation values, and providing meaningful outreach and engagement opportunities, are equally critical to our success.

SLT's Strategic Goals

I. Conservation: The essential character of the Stowe landscape is conserved through pro-active and responsive land protection.

2. Stewardship: SLT conserved and owned properties are sustainably managed to protect their conservation values.

3. Fundraising: SLT has sufficient funds to meet its conservation goals and fulfill its perpetual conservation obligations, steward-ship obligations and annual operations.

4. Solid Organization: Effective people and systems throughout the organization provide direction, resources, and follow-through to support SLT's mission.

5. Reputation: SLT has a solid reputation as an essential community institution.

SLT's Board of Directors is working hard to develop a wide array of strategies that support these goals and is on track to complete the plan by the end of May. If you have comments, thoughts or ideas please share them with us.

Looking Ahead to a Busy Field Season



Kirchner Woods

Since April 2009 when Kirchner Woods was purchased, Stowe Land Trust has tackled one project after another to make this property a community resource capable of standing the test of time. The parking area and trails are complete and look as if they belong. Your patience with the lack of signage was appreciated last fall and winter as we worked to inventory sign needs and come up with a design. The signs are currently being fabricated and trail markers will be ready for installation by volunteers on National Trails Day - June 4th.

At the same time we are working with Sally Stetson, who has generously donated her time, to design a trail map for Kirchner Woods. A final draft should hit the printing press next month. The trail map will be available online and at the trailhead kiosk.

Before Stowe Land Trust took ownership of the 75 acre property, a management plan was developed to guide resource management and the construction of trails and related amenities. With so much accomplished since adopting the management plan, we will work to update the document this summer with the help of interns from UVM.

UVM's LANDS interns are students with experience or a focus

on natural resouces, supervised by graduate students from UVM's Field Naturalist program. SLT submitted a proposal this winter to have the group of students complete inventories and assessments for exotic invasive plants and wildlife habitat. With these two assessments completed we will be able to incorporate activities into the management plan to support permanent protection of Kirchner Woods.

Wiessner Woods

2012 will mark the 20th anniversary of conservation for Wiessner Woods. In preparation for this milestone we will replace some of the older signs that are showing wear (or teeth marks from porcupines) and install a few new signs in some of the more confusing spots on the trail.

Future phases of trail work are also planned to improve trail conditions on the property. We will prioritize areas that need work this year so staff and volunteers can work together on important trail projects to celebrate the 20th anniversary.

During National Trails Day on June 4th this year, volunteers will help spruce up the trails for the summer hiking season as well as replace the colored trail blazes that help mark the way in winter.

Mill Trail

The historic Moravian Cabin continues to be a priority for Stowe Land Trust. Using recommendations made by Cushman Design Group last year, we submitted a proposal for funding to the Vermont Housing and Conservation Board. If awarded funds will support restoration efforts that will allow us to open the Moravian Cabin to the public.

Another grant proposal was submitted to the Recreation Trails Grant Program to provide funding for substantial trail work on the trail from the Moravian Cabin to Bingham Falls. If awarded, we will work with a professional trail builder and volunteers to improve drainage along nearly a mile of the trail late this summer or fall.

Conservation Stewards: Fun Outdoor Volunteering!

Annual monitoring of conserved lands takes you to the fringes of spectacular protected properties. Volunteers also play an integral role in achieving SLT's goal of ensuring the long term integrity of its conserved lands.

Volunteer Steward Training Saturday, May 21st 9am -1:30pm

Training in the field with State Lands Forester Dave Wilcox will teach you about observing and interpreting changes in the forest. Training will also include a presentation about SLT's Stewardship Program and skills for finding parcel boundaries.
