On Wednesday, May 30th Stowe Land Trust closed on the purchase of the 258 acre Cady Hill Forest and transferred ownership to the Town of Stowe. Stowe Land Trust's staff and board would like to offer our most sincere thanks to the Stowe community for its role in the successful completion of the Cady Hill Forest conservation project.

Beginning with the town's vote in March to allocate \$288,000 of the local option tax, and ending with community contributions totaling \$450,000, Stowe's support was critical to completing the \$1,560,000 project. The business community rallied like never before, with many businesses contributing in their own unique way, each one making a meaningful difference in the project's success.

Members of the Selectboard and town officials are also to be commended for their constant support and willingness to take ownership of such a significant property in the heart of the community. Cady Hill Forest is now a community owned centerpiece of Stowe recreation and natural beauty thanks to their foresight and leadership.

SLT was fortunate to have had many great partners, including the Stowe Mountain Bike Club, who galvanized the community behind

In 2011 Stowe Land Trust received a grant from the Norcross Foundation to cover the cost of a major upgrade to the website. We recognized that our website is a really important way for us to share information about the organization as well as connect people with the fascinating stories behind the conserved land in our community. The grant allowed us to work with Ecopixel, a Burlington-based web development company, to take a look at ways to increase functionality and improve the way people interact with Stowe Land Trust online.

One of our favorite new features is the categorization of conserved lands by value - farm and forest land, recreation, and scenic views. Now visitors to our site can quickly find conserved lands they are interested in. Visit stowelandtrust.org to take a look!




13th Annual Golf Tournament Summer Cocktail Party and Calcutta Social








The campaign to protect Cady Hill Forest is an ideal demonstration of the impact Pinnacle Society members have on Stowe Land Trust's ability to pursue important conservation projects. t began as a whisper and grew to a rallying cry "Corn, not cars! Preserve Stowe and the Mayo Farm." Threats of development at Mayo Farm in the mid-80's sent Stowe and the fledgling Stowe Land Trust on a path they haven't wavered from for the last 25 years. There was talk of condominiums, a golf course, and other rumors about potential development on the 235 acre property. But, the community wouldn't stand for the loss of so much prime agricultural land and open space so close to downtown.

The first of many partnerships between Stowe Land Trust and the Town of Stowe led to the purchase of Mayo Farm by the Town. According to the current management plan, a number of local organizations, interest groups and advocates proposed various uses for the property. In order to adequately address the variety of demands and avoid conflicts, the Town decided to develop a long range management plan for Mayo Farm. Its purpose was to provide a framework for protecting the conservation values while at the same time allowing a variety of activities to take place on the property.

Management Priorities

The management plan identifies a set of prior-Mountain Views ities for the management of Mayo Farm. The priorities are as follows:

- Preserve open green space
- Preserve scenic and other aesthetic resource values
- Conserve soil productivity
- Conserve wildlife habitat
- · Provide for public open space
- Protect the ecological processes that sustain the above natural resource values
- Maintain the function and appearance of the Farm's working landscape
- · Improve natural vegetation
- Preserve the historic Wade Meadow and Parker barns
- Provide opportunities for agricultural uses, events, team sport uses, dispersed recreational uses and other municipal uses.

Land Use Zones

The conservation easement, later granted to Stowe Land Trust, established Land Use Zones as an additional means of managing the various uses taking place at Mayo Farm. Specific uses are permitted in each zone as a way to minimize conflicts. Some uses are allowed on the entire property.

The five zones consist of:

- Agriculture Zone
- · Ballfield Recreation Zone
- Community Events Zone
- Cemetery Expansion Zone
- Municipal Purposes Zone

The management plan calls for an annual review facilitated by the Conservation Commission in order to regularly engage the community in management of this valuable resource. Any community member is allowed to propose amedments to the plan. Anyone interested is encouraged to submit their thoughts in writing to the Director of Planning. Submit your comments on the management plan to the Director of Planning by August 6, 2012.

Attend the public hearing on September 5, 2012 to learn about proposed amendments to the plan.
